## **Methods to Make Deposits to Your Funderstone Securities/Futures Account**

Dear Client,

In order to ensure our mutual compliance with Anti-Money Laundering and Counter-Financing of Terrorism regulations, **Funderstone Securities Limited and Funderstone Futures Limited (“Funderstone”)** will **not accept any third party deposits to your account if prior approval has not been granted by Funderstone.** Therefore, deposits to your Funderstone account should originate from or be drawn upon a bank account in your own name, NOT the name of a third party.

In addition, Funderstone does NOT accept cash deposits.

Please notify us of your deposit of funds according to the steps outlined below, which will enable us to confirm the identity of the depositor. Failure to follow these steps will unfortunately result in delays in crediting the funds to your Funderstone account and you will be liable for any consequences of any delayed credits, including, but not limited to, forced liquidations resulting from failure to settle a margin call on time or interest charges.

### **For deposit made by CHATS or telegraphic transfer (‘T/T’)**

Generally, deposits made by CHATS or T/T are accompanied with the depositors’ account name. To facilitate the deposit process, please send us further notification informing us of **your Funderstone account number** to be credited the funds and the amount remitted by email at [deposits@funderstonesec.com](mailto:deposits@funderstonesec.com), by WhatsApp at +852 6205-2556 or by facsimile at 2913-9870.

### **For deposit made by cheque**

Please send us a message stating **your Funderstone account number** with a copy/image of BOTH the cheque and the bank deposit slip either by email at [deposits@funderstonesec.com](mailto:deposits@funderstonesec.com), by WhatsApp at +852 6205-2556 or by facsimile at 2913-9870.

Either your name, as the payer, must be clearly visible on the cheque or your bank account number on the cheque must match Funderstone’s record of your bank account number. If you fail to provide us with a copy/image of the cheque, we will need to request the bank to provide it to us at your expense. This will cause a delay of approximately 2 weeks in crediting the funds to your account.

### **For deposit made by ATM or bank transfer**

Please send us a message stating **your Funderstone account number** with a copy of the bank deposit slip either by email at [deposits@funderstonesec.com](mailto:deposits@funderstonesec.com), by WhatsApp at +852 6205-2556 or by facsimile at 2913-9870.

If your name is partially hidden on the deposit slip for privacy reasons, please ensure that the depositor's bank account number is at least partially visible in order that we can match it to the record we have for your bank account. If you fail to provide us with a copy of the deposit slip showing sufficient information, we will need to request the bank to provide the depositor's details to us at your expense. This will cause a delay of approximately 2 weeks in crediting the funds to your account.

#### **For deposit made by other methods**

If you make a deposit to our bank accounts by other methods, please ensure that your name, as the depositor, is visible on the confirmation and email a scanned copy of the confirmation to us at [deposits@funderstonesec.com](mailto:deposits@funderstonesec.com) and state **your Funderstone account number** in the message.

#### **Important Notes**

To avoid any delays in credits, you should always have your bank accounts registered with Funderstone prior to depositing funds. To register your bank account details, please complete and return the "Change of Information / New Password Request Form" to our office. The "Change of Information / New Password Request Form" is available for download on [http://www.funderstonesec.com/download/LSL\\_ChangeInfo.pdf](http://www.funderstonesec.com/download/LSL_ChangeInfo.pdf). You may register more than one bank account provided that each account is in your own name.

If any deposit is found to have been made from a third party, Funderstone shall conduct appropriate enquiries about the third party funds, such as questioning the reason for such deposit and requesting supporting documentation. This will cause either delays or rejection on the funds. Funderstone reserves the right to reject deposits made by a third party if, in our sole judgement, acceptance of the deposit will increase regulatory risks for Funderstone. We will then return the rejected funds to the depositor. You will be asked to provide authorization to return such funds, and will be liable for all bank charges incurred.
